Morris Group, Inc. is a duly licensed broker-dealer and member of FINRA and SIPC. When appropriate, registered representatives of Morris Group, Inc. will offer commission-based mutual funds, variable annuities, unit investment trusts, stocks, and/or bonds to clients. Although the client may choose to implement the recommended securities transaction through any third-party broker-dealer, the registered representatives of Morris Group, Inc. may recommend the use of Morris Group, Inc. provided that the recommendation is consistent with Intrepid Financial Planning Group, LLC's fiduciary obligations to the client.

As a registered representative with Morris Group, Inc., Ms. Wheeler would receive commissions for any securities transactions affected through Morris Group, Inc.
